Take photos of the affected areas of your skin, preferably using your smartphone, from several angles and distances. Make sure the resolution is good before uploading the photos to our secure server.

Register for your secure patient account

CAUTION: Photo Upload



Upload at least 1 photo, preferably 3 or more, if possible.

Take at least 1 overview photo and 2-3 close-up photos

Take the photos against a light background.

Make sure that the photos are not blurred.

A photo may have a maximum size of 10 MB.

Usually, a maximum of 5 photos can be uploaded.

Please also note the illustrations shown for taking an overview picture!

Product Description



Intended Purpose: Derma2go is a software as a medical device that offers dermatological telemedical services. It supports structured, asynchronous communication between users (including patients) and dermatologists (specialized medical doctors). This includes the possibility to send medical enquiries to the dermatologists by choosing a price plan (if applicable), uploading photos and answering medical questionnaires (that can be adapted by the institution/dermatologist and include dynamic functions). The dermatologists can answer these enquiries, possibly including a suspected diagnosis and prescription. The users can order the prescribed medication and can request follow-up consultations.

Intended Patient Population: The use of derma2go is not restricted to any patient population. Patients that are unable to use derma2go on their own (e. g. children, elderly or disabled persons) might use it with help or support from others.

Intended Users in the medical context of use:

Patients (lay person; this includes lay persons using the product on behalf of the patient), Dermatologists (medical doctor/healthcare professional), Referring doctors/pharmacies (medical doctor/healthcare professional), Technical support (lay person)

Note: Lay person means an individual who does not have formal education in a relevant field of healthcare or medical discipline.

Intended Users in the non-medical context of use: Secretary (lay person), Biller (lay person)

Medical Indications: Dermatological clinical pictures/(potential) pathologies, changes to the entire human skin; these conditions are covered by the following ICD-10 codes: L00-L99 Diseases of the skin and subcutaneous tissue, R21 Rash and other nonspecific skin eruption, R22 Localized swelling, mass and lump of skin and subcutaneous tissue

Contraindications: All non-dermatological/non-allergic indications, acute life-threatening situations

Product Description



Intended Use:

derma2go is intended to be used on a mobile device (e. g. smartphone) or stationary device (e. g. PC) and can be used in any environment, including domestic environments, outdoor environments, medical offices and pharmacies.

To ensure a sufficient quality of the photos used for the diagnosis, it is recommended to make sure there is sufficient light when taking the photos. Depending on the case of application, it is advisable to choose an environment that guarantees sufficient privacy.

derma2go is normally intended for continuous use for less than 60 minutes (transient use). The frequency of use is not limited. As derma2go is software only, it is not invasive and there is not body contact.

Claims:

Clinical Performance:

- Derma2go enables diagnoses made by doctors on the basis of image material with >85% agreement with specialist diagnoses on site (diagnostic concordance)
- Derma2go enables diagnosis and treatment without a doctor's appointment (thus avoiding visits to the doctor) in an average of 79% of cases
- In 98.15% of cases, patient concerns can be partially (12.50%) or completely (85,65%) resolved via derma2go from the doctors of point of view
- In 90.50% of cases, patient concerns can be partially (24.70%) or completely (65.80%) resolved via derma2go from the patients ´ point of view

- Quick diagnosis (usually possible within 24 hours)
- Reducing the time it takes for patients to see a doctor and receive a diagnosis
- Access to dermatologists even in more rural regions

Installation: Derma2go is available as a mobile app for iOS (iPhone) via Apple AppStore and for Android via Google PlayStore. The app is installed automatically after downloading it. The app can be downloaded and installed by the user him-/herself. An internet connection is required to download and install the app.

The web application can be accessed via web browser. An internet connection is required.



CAUTION: Compatibility Requirements

derma2go Mobile App:

- iOS 18 or higher is required
- Android 10 or higher is required

The derma2go web application is compatible with all common web browsers.

Maintenance: Derma2go is maintained through regular updates that are provided directly through the Apple AppStore/Google PlayStore or directly in the web application.

The expected lifetime of the product is estimated to 2 years. The expected lifetime is tied to factors such as active maintenance (e.g., updates, vulnerability scanning, patch support), market relevance (including clinical benefit), compatibility with host environments and ongoing acceptability of the benefit-risk ratio.

Deletion: The mobile application can be uninstalled on the mobile device. The web application does not have to be uninstalled, as it is not installed locally on the device.
